Save the Dates - Our Inclusive Path Forward: Addressing Inequities in STEM Education

Co-sponsored by a diverse collection of Ohio State colleges and offices (including CFAES) this seminar series brings national leaders in recruiting, retaining and graduating a diverse population of STEM students to Ohio State. The goal of this seminar series is to provide opportunities for faculty, staff and students to learn best practices in the field and envision how to implement those practices. Nationally and within the state of Ohio, there continues to be increased demand for STEM graduates. However, approximately half of all students who begin in STEM majors change to non-STEM majors after two years of study, and underrepresented STEM students (e.g., first-generation students, racial and ethnic minorities) make up a disproportionally large number of those students. Addressing the attrition inequities in STEM majors and graduates requires addressing students' experiences both inside and outside of STEM classrooms. The lectures are scheduled for 6 p.m. on March 3, 10, 24, 31 and April 7 and 14. View information about the speakers and their presentations here. If you know first- or second-year students who have faced academic challenges this year, please encourage them to participate in the SpringForward academic success support program. Students who complete the class consistently report feeling more supported, motivated and better connected to Ohio State.

Deadline Extended for Spring Semester Dependent Tuition Assistance

The university is extending the deadline for eligible employees to apply for dependent tuition assistance (DTA) for spring semester 2021 to March 5 at 11:59 p.m. This one-time extension for the current semester only is in response to potential challenges with enrolling due to the recent transition to Workday. To complete enrollment, employees must submit a completed DTA application electronically via HR Connection or fax it to 614-292-7813 by the deadline. Employees must meet eligibility guidelines, including being employed in an eligible appointment on the first day of the spring 2021 term on Jan. 11. Read more.
