CFAES Community,

As we approach the official first day of spring, there is much to feel optimistic about especially as we start thinking about the end of the academic year, the recently announced in-person spring commencement, and the improving state of the pandemic. At the same time, we are all continuing to feel the toll of COVID-19. Stress, anxiety and depression are on the rise, and there has been a national increase in hate crimes targeting Asian, Pacific Islander, and Desi Americans (APISA) due to the pandemic (see message from Vice Provost Moore). We all need to continue to practice self-care and take care of one another.

- The second <u>instructional break</u> is March 31-April 1. No classes are to be held on those days and academic assignments should reflect that students are not expected to be completing work those days. Please honor the break, and remember that April 2 is a conversion day, so classes that normally take place on Wednesdays will be held that day.
- While students and 9-month faculty are not expected to work during the instructional break, many
 other employees will be working those days. In recognition of the stress that so many are feeling,
 managers should consider what they can do to lighten the burden both during the instructional
 break and as a part of normal work cycles. Find ways to reduce the number of meetings, limit off-hours
 emails and consider what you can do to take care of your colleagues.
- Utilize the <u>Mental Health and Wellness</u> resources compiled by the university which include resources
 that can help build resiliency and enhance mental, emotional and physical health and well-being. You
 will also find information on mental health concerns to watch for and places to find help, resources
 that can assist with achieving work/school-life balance, financial wellness courses, and guidance for
 parenting during a pandemic.

Thank you for all your continued efforts and consideration of others in our CFAES community.

Weekly Testing Available to Faculty and Staff Working on Campus Regularly

Asymptomatic faculty and staff who are regularly working on the Columbus campus can now schedule weekly COVID-19 testing at Jesse Owens North Recreation Center via MyChart. This new testing program is available due to increased capacity at the university's Applied Microbiology Services Laboratory (AMSL) and is meant to provide employees with an additional testing option and critical information to help themselves and members of their household feel safe. This program is not meant for intermittent, mid-quarantine or symptomatic testing. As a reminder, regional campus employees who are working in person are encouraged to test on their campuses each week. Read more.

Guidance for People Who Have Been Vaccinated

The <u>Centers for Disease Control and Prevention released guidance</u> that says it is safe for fully vaccinated people to relax safety measures in non-public, indoor spaces when they are spending time with other fully vaccinated people. While this news is encouraging for those who have been vaccinated, it is important to remember that regardless of vaccination status, everyone on campus is still required to continue following safe and healthy behaviors, including wearing masks properly, staying at least six feet apart from others, avoiding crowds, washing hands often, testing when required and quarantining when directed. As part of Ohio State's commitment to carry out its research mission, the Office of Research Compliance has worked with multiple stakeholders to revise the current University Policy and Procedures Concerning Research Misconduct. The new Research Misconduct Policy ensures that the university's processes for handling allegations of research misconduct are compliant with federal regulations and emerging best practices and protects the integrity and reputation of the university and its scholars from false or unproven allegations of research misconduct. This policy went into effect on March 1 and applies to all individuals involved with research activities. Read more.

 use of eActivity has not changed. However, there are some differences from the legacy eActivity

The grants, offered by the Office of Human Resources in partnership with the University Staff Advisory Committee, are a way to further and enhance your professional development. Applications for the Staff Career Development Grants will be accepted from **March 1 until March 31, 2021**. Eligible staff can apply for funding for professional development opportunities occurring between May 2021 through September 2021. Awards will be provided as a reimbursement of up to \$1,250

for individuals, \$1,750 for groups of 2-10, and \$2,000 for groups of 11 more.
