Today, we are finishing our first week back with students and things went well thanks to all of you. I want to recognize a couple of recent good news stories from our college. In the midst of our transition, ATI was named among the best trade schools in America (finance.yahoo.com/news/best-trade-schools-america-184944603.html), and Ben Brown and Brooke Beam were named in AgGrad's 30 under 30 for 2020. Also, a current natural resource management major, Caleb Hineman, was announced as the new Undergraduate Student Government (USG) Vice President. Please join me in congratulating all.

I recognize that each of you are juggling many different things both for your professional life, and your personal life. I also recognize that things keep changing and there's a lot of information and processes to change. We remain committed to helping you as much as possible.

## **Hiring Pause Guidance**

As shared in the March 25<sup>th</sup> On Campus today, the university has implemented a hiring pause. Below we have recapped the overview of the impacts of this decision for our college in addition to provide clarity and action steps surrounding the reference to any applicable exceptions.

- All positions that have accepted offers with confirmed start dates will proceed as normal. HR Consultants will coordinate onboarding logistics with hiring managers and serve as the point of contact for general questions.
- No positions that were vacant as of noon on March 20, 2020, should be filled unless an offer has already been extended. Those positions may be filled if a candidate accepts by Friday, March 27, 2020, and has an identified start date. HR Consultants have a list of candidates that fall in this category and will reach out to hiring managers.
- No new positions should be created without prior approval
- Any hiring through June 30, 2020, should focus on maintaining adequate staffing levels in these essential service areas within CFAES:
  - Law enforcement and public safety
  - Facility utilities
  - Residential support

Key faculty positions

- Key research positions
- Others determined to be essential by the university

We understand that there are many needs for hiring across our college, as a result we are following up with department and unit leaders to provide a procedure for submitting requests to continue or create recruiting opportunities.

## **Discretionary Spending**

Beyond the temporary hiring pause, we are asking all employees to limit discretionary spending, including procurement activity. The President has directed every area of the university to make all attempts to retain as much of our current (FY2020) budget as possible. We will be implementing some additional guidelines to aid with this process over the next week.

## **Grading policy changes for Spring 2020**

The university has approved several changes that give undergraduate students new options for grading this semester. These changes, include:

- Extending the deadline for you to request the Pass/Non-Pass option (PA/NP) until April 17, 2020
- Expanding the range of classes eligible for the PA/NP option to include GE courses (the option previously was available only for electives)

In addition to these provisions, and only for the current semester, CFAES will allow undergraduate students to choose to have major or minor courses graded on a PA/NP basis. A request for each course will need to be made by April 17 to elect the option. We will be communicating this to students and through social media.

## **Reduced Custodial Services and Waste Pickup**

# IT Services and Support Available 24/7

During this time, please continue & do not hesitate to reach out to the <u>IT Service Desk</u> for IT related issues. For phone, email, and self-service requests, support is available 24 hours per day, 7 days per week. Even with the large shift to teleworking, we are still effectively coordinating replacements of faulty equipment at specific set times on campus.

## **IT Equipment and New Hires**

At this time, OCIO requests your patience and understanding as we are all experiencing interruptions to our normal operations. All requests for IT equipment for new hires will be handled on a case by case basis to determine the best way to facilitate each request. Hiring managers should expect contact from an OCIO associate in advance of the requested date of dispatch for any equipment to provide instructions on how equipment can be picked up or shipped to the employee, which will include instructions on next steps once the equipment is received. All onboarding technology requests should continue to be made through the college-wide Technology Request Form, which can be initiated by your Human Resources Consultant. For all questions related to IT equipment, please contact the IT Service Desk.
