CFAES Community,

This past weekend, we celebrated commencement with our graduating students. Their accomplishments are a testament to their determination and to the support of an entire community focused on their success. Though we wish the weather would have been better, it was great to celebrate in person at CFAES Wooster and in the Shoe in Columbus. Thank you to everyone who made these events a success.

When summer classes start Wednesday, the CFAES community should continue to follow the protocols listed on <u>Safe and Healthy Buckeyes website</u>, including wearing masks and maintaining physical distancing. Most guidelines from spring semester remain in place, although <u>events and gatherings</u> are now permitted if organizers follow the appropriate approval process.

As we continue planning for return to offices/campuses, we know faculty and staff whose offices reside on the Columbus and CFAES Wooster campuses may be wondering about expectations around telework and returning to the office. Faculty generally know what teaching will look like in the fall and for our Extension offices on the Statewide Campus, a planning process/expectation for statewide campus staff is in place for the summer. Unless you have talked about a change with your supervisor, we aren't expecting major shifts in the amount of telework versus being in the office this summer. We won't ask employees to suddenly change from their current schedule to being in the office full time. We expect additional guidance soon from the Office of Human Resources for managers and employees. Once that information is available, we will ask unit heads to have a general plan in place by July 1 for teams/individual staff for implementing in mid-August.

Please join me in congratulating Dr. Sathya Gopalakrishnan and Dr. Caryn Filson on their recent university awards. Dr. Sathya Gopalakrishnan, associate professor in the Department of Agricultural, Environmental and Development Economics, was selected to receive a 2021 President and Provost's Award for Distinguished Faculty Service. This award recognizes exemplary service at the university level and, this year, Sathya is one of three faculty members to be chosen for this honor. Dr. Caryn Filson, assistant professor in the Department of Agricultural Communication, Education, and Leadership, was selected to receive a 2021 Alumni Award for Distinguished Teaching. This award annually recognizes no more than 10 faculty members for their teaching excellence.

I would also like to congratulate Dr. Emily Buck, associate professor in the Department of Agricultural Communication, Education, and Leadership on her selection to the Big Ten Academic Alliance Academic Leadership Program. She is one of six OSU Fellows selected for this prestigious recognition.
