New for summer 2021, applications will be required for faculty and staff tuition assistance. The enrollment window for summer semester 2021 ends May 14. Eligible faculty and staff can apply in Workday or with paper forms. Applications for dependent tuition assistance must also continue to be submitted each term. Staring summer 2021, both parents will be required to enroll in dependent tuition assistance to qualify for the 75% benefit.
