

Bruce A. McPheron Named Ohio State Provost

After a national search, Ohio State University President Michael V. Drake named Bruce A. McPheron executive vice president and provost. McPheron previously served as interim provost and, for three years, vice president for agricultural administration and dean of the College of Food, Agricultural, and Environmental Sciences. As Ohio State's chief academic officer, he will oversee and help to advance the educational mission of The Ohio State University.

A graduate of Ohio State, McPheron returned to his Alma Mater in 2012 and began leading a statewide effort led by Ohio State faculty and staff to ensure clean drinking water for all Ohioans. He has earned multiple national awards for excellence in leadership and is the sole person to hold elected leadership roles on three APLU agricultural boards. An entomologist by training and an active Twitter user under the handle @medflygenes, he is widely recognized for his scientific expertise. His research focusing



on the use of genetic tools to examine population structure in pest insects has been adopted by state, federal and international agencies. McPheron has taught a wide range of classes in entomology and has traveled internationally sharing his research.

McPheron earned a B.S. at Ohio State and M.S. and Ph.D. degrees from the University of Illinois. He has almost 20 years of leadership experience in higher education, previously serving as dean of Penn State University's College of Agricultural Sciences.

DR. LONNIE KING APPOINTED ACTING DEAN OF CFAES

Dr. Lonnie J. King has been appointed acting dean and vice president for agricultural administration for the College of Food, Agricultural, and Environmental Sciences (CFAES) at The Ohio State University.

"King's extensive leadership experience and countless scientific contributions align well with CFAES's teaching and learning, research and innovation, and outreach and engagement missions," Provost McPheron said. For example, in addition to serving as dean of Ohio State's College of Veterinary Medicine (2009-2015), King had also served as a dean at Michigan State (1996-2006). Moreover, he had served as director of the Centers for Disease Control and Prevention's National Center for Zoonotic, Vector-Borne and Enteric Diseases and led initiatives in public health, disease prevention, policy development and research.



King also worked in global trade agreements and has testified before the U. S. Congress on issues of emerging diseases in his role as the nation's chief veterinarian. Among his many distinctive honors, he is an elected member of the National Academy of Medicine.

DR. TOM JANINI APPOINTED INTERIM DEAN AT ATI



Thomas Janini, associate professor of chemistry and chairman of the arts, science, and business technologies division at ATI, will take over the interim director position from Jim Kinder on Aug. 1 and serve in the post until a new director is appointed.

A native of northeast Ohio, Janini holds a Ph.D. in organic chemistry from Kent State University. He worked for nearly a decade in the coatings and pharmaceutical industries in New Jersey and then returned to Ohio to teach. He joined Ohio State ATI in 2007 as assistant professor of Chemistry.

From the Desk of Elayne Siegfried, CFAES Human Resources Director

As you may or may not be aware, updates to the federal Fair Labor Standards Act (FLSA) released on May 18, 2016, require employers to change certain policies and practices in order to comply with the law.

The Department of Labor's updates expanded the number of employees who are eligible for overtime pay. Employees who make less than \$47,476 per year in base salary will be eligible to receive overtime pay when working more than 40 hours in a week, except for those excluded by the statute. Affected employees at Ohio State will transition to non-exempt status. After that, affected employees will be paid for all hours worked, including overtime.

The Department of Labor has given employers until December 1, 2016, to implement the changes. Work teams representing stakeholders from across the university are working on an implementation plan to comply with the new regulations and support the Ohio State community during this change.


The university has assured us of their commitment to support affected employees, their supervisors and local units as we work to implement the necessary changes. College Leadership and our team will work in conjunction with OHR to provide assistance to employees, supervisors and leaders in learning and implementing updated internal policies and processes.

CFAES Interim Associate Dean for Research

Jerry Bigham is serving as interim associate dean for research and graduate education following Steve Slack's transition out of that position on Dec. 31, 2015. Jerry has had a distinguished career at Ohio State and is uniquely qualified to serve in this important position during this leadership transition. He came to the college in 1977 as an assistant professor in soil science and built an outstanding scholarship agenda throughout his career.

Jerry has served in a number of administrative positions in the college since 2002, when he was the research coordinator for the School of Natural Resources (now the School of Environment and Natural Resources). He had a successful tenure as director of SENR from 2005 to 2009 and has since served in a variety of capacities supporting the college research enterprise.

College Creates Annual Lecture Series in Honor of Retired OARDC Director Dr. Steve Slack



The College of Food, Agricultural, and Environmental Sciences at The Ohio State University has announced the creation of a research lecture series in recognition of Steve Slack, who served as director of the Ohio Agricultural Research and Development Center for 16 years until his retirement in December 2015.

The Steven A. Slack Lecture on Innovative Research in AgBiosciences will be given every year during the OARDC Annual Research Conference by a nationally and internationally respected scholar in agricultural biosciences who has made or is on a path to making significant, meaningful contributions to his or her field of expertise. The largest university agbiosciences research center in the U.S., OARDC is the research arm of CFAES.

"Steve championed the role of research in the college and also broadened its impact through engagement with internal and external partners," said Ron Hendrick, former CFAES dean and vice president for agricultural administration. "He led the college's research enterprise through significant growth and change that allowed scientists to focus on significant societal challenges. This lecture series recognizes his commitment to research and to this institution."

In addition to being regarded as an expert in his or her discipline, the chosen lecturer must conduct work that has a direct impact on the lives of agricultural producers, consumers, researchers or educators.

Also, individuals selected for the Steven A. Slack Lecture on Innovative Research in AgBiosciences are expected to challenge listeners to be bold and innovative in their scholarship, and to move beyond the simple and address the complex so that broad, meaningful impact is achieved, according to the lecture series' description.

The inaugural lecture was delivered by Jan Leach, professor in the Department of Bioagricultural Sciences and Pest Management at Colorado State University at the OARDC Annual Research Conference held on April 16 at the Shisler Conference Center on Wooster's campus. Leach is an expert on molecular plant-microbe interactions. Her laboratory studies genes in quantitative trait loci (QTL), which control many important plant characteristics such as disease resistance, biomass accumulation, yield and health benefits. The long-term goal of her research is to identify genetic locations where crops can be modified to improve disease resistance and biomass accumulation for sustainable agricultural production.

Slack spent over four decades dedicated to teaching, research and administration. He joined OARDC in 1999 after serving as chair of the Department of Plant Pathology at Cornell University, where he was also the Henry and Mildred Uihlein Professor of Plant Pathology. Before that, he was a faculty member in the Department of Plant Pathology at the University of Wisconsin-Madison.

Slack's key accomplishments at OARDC included tripling extramural funding for the organization; leading an extensive review of OARDC programs and its economic impact in Ohio that identified three core investment areas (food, environment and bioeconomy), which later became the college's strategic areas; and supporting public-private partnerships, including the BioHio Research Park.

He also oversaw important facility improvements, including construction of the Ralph Regula Plant and Animal Agrosecurity Research facility, the state's only public BSL-3 Ag biosafety lab.



Over 1,500 people attended Wooster's Scarlet, Gray, and Green Fair on Tuesday, April 19, 2016 on the OSU Wooster Campus. The festival celebrated, educated and demonstrated this year's theme that "Green Is For Life!"

Vendors set up in and around Fisher Auditorium and shared information about environmentally friendly products and green living. There were also several opportunities for participants to recycle, and an additional 300 visitors utilized the drive through recycling to add up to the following recycling totals:

- ⇒ Sanmandy produced 2,350 pounds of pulp through paper recycling
- ⇒ Habitat ReStore took in 1,200 cans of paint to recycle
- ⇒ 736 fluorescent tubes, 412 CFLs were collected by EcoCycle Solutions of Ohio
- ⇒ 150 automobile tires
- ⇒ 80 pounds of batteries

The first 200 recycling participants receive a \$2.50 coupon redeemable with any of the sustainable food vendors. Vendors included Zydeco Bistro, Get Stuffed Solar Powered Eatery, Scott's Fire and Ice, and Hartzler Family Dairy.

The fair also included a Renewable Energy Workshop that was attended by 60 people. The workshop included talks on fossil fuels, climate change, motor fuels, and solar energy, with panelists available for a questions and answer session.

The fair also featured 51 commercial and non-profit environmental exhibits. OSU exhibitors included: Ag-Urban Landscape Ecology Lab, OARDC/AMP,OARDC/OFFER, Ohio State ATI, Ohio State ATI Landscape and Greenhouse Clubs, Ohio State Beekeepers Association and Secrest Arboretum. Other popular exhibits were Stark-Tusc-Wayne Recycling District, Wayne County Rails to Trail, Quasar Energy Group, Frito Lay, Green Field Farms, Local Roots, Akron Zoo, The Wilderness Center, Bold Alternatives Solar, Green Energy Ohio, and the Pollinator Stewardship Council.

Medway Drug Enforcement Agency was on-hand for the collection of prescription medications. One hundred forty pounds of prescription medicines were collected to be disposed of by incinerating.
