We are pleased to announce the appointment of Dr. Tim Haab as Professor and Director of the School of Environment and Natural Resources (SENR) in the College of Food, Agricultural, and Environmental Sciences (CFAES) at The Ohio State University (OSU) effective July 1, 2024 through June 30, 2028 subject to the appropriate review process, and Board of Trustees approval of both appointments.

Dr. Haab has served as Interim Director of SENR since August of 2023 as well as serving as Dean's Chair for Transformative Initiatives. Prior to this appointment, Dr. Haab served as Chair of the CFAES Department of Agricultural, Environmental, and Development Economics for 13 years.

Dr. Haab is an environmental economist who focuses on methods and applications for the valuation of environmental and natural resources. He earned his B.A. in Economics and his Ph.D. in Environmental and Resource Economics from the University of Maryland. After receiving his Ph.D., he spent five years on the faculty of East Carolina University before joining Ohio State in the Department of Agricultural, Environmental, and Development Economics in 2000.

During his term as Director of SENR, Dr. Haab will:

- Develop strategic areas of excellence to build a clear identity for SENR.
- Continue to work with the faculty on curating and a governance structure.
- Continue to identify and capitalize on ways of integrating the work of SENR across the college.
